FEE SCHEDULE

Egg Bank Cycle Fee

\$19,500

Fee includes the following services: consent signing office visit with the physician; psychological consult; selection of donor; lot of six (6) eggs; shipping (if applicable); egg lot thaw, ICSI (intracytoplasmic sperm injection), and embryo incubation; embryo transfer; ultrasound and blood monitoring; pregnancy test; OB ultrasound.

The payment schedule for the cycle is as follows:

- \$500 Treatment Plan Consult and Consents signing (non-refundable)
- \$250 Donor Database Access Fee (non-refundable)
- \$8,750 due within five (5) days of securing donor egg lot
- \$9,000 due prior to cycle start

Services Not Included in the Egg Bank Cycle Fee

The initial office visit with the physician and all pre-cycle testing for the recipient patient may be submitted to the patient's health insurance carrier should benefits be available, otherwise the cost for the office visit and testing is the responsibility of the patient. IVF New England financial services representatives will complete an insurance benefits review prior to the initial consult with the physician, and if insurance benefits are not applicable for the initial visit or pre-cycle testing, IVF New England will require the patient to provide a deposit for such services. The cost of medications for the recipient patient is the responsibility of the patient.

The fee for cryopreservation of embryos not transferred in an egg bank cycle is the responsibility of the patient (\$1000). The monthly embryo storage fee (\$85) is waived for the month in which the cryopreservation is completed as well as the following two (2) months, with monthly storage invoicing commencing thereafter.

Patients choosing not to monitor at IVF New England facilities will have their overall fee reduced by \$500. Monitoring services not provided at IVF New England are the financial responsibility of the patient.

Cycle Cancellation Fees

The following fees will be incurred by the patient for a non clinical or patient requested cancellation of an Egg Bank Cycle:

• Cancelled prior to egg lot receipt at IVF

\$ 2,500.00

Cancelled after egg lot receipt at IVF

\$12,000.00*

*An egg lot shipped to IVF New England for the cycle *cannot* be returned to MEB for a refund. The egg lot can be stored in our laboratory or destroyed. Egg lots in long term storage at IVF New England will incur storage fees of \$70 per month following the initial 90 days of storage until the egg lot is removed from storage at IVF New England.

A cycle cancelled prior to transfer due to no embryo(s) available are subject to MEB approval for a no cost replacement egg lot*** and a repeat cycle at IVF New England with no additional fees.

Cycles including PGD testing do not qualify for a replacement egg lot and subsequent cycle at no additional fee.

***Exclusions to the MEB replacement lot include, but are not limited to: severe male factor (<5million total motile sperm, <1% normal morphology) usage of surgically retrieved sperm, smoking in the male partner and PGD testing.
