

Terms of Use

Use of VoiceTx ("VoiceTx" or the "App") and its contents is subject to the following terms and conditions. Boston University (BU), through the Stepp Lab at BU's Sargent College (the "Stepp Lab") operates the App. As used in these Terms of Use, the terms "we," "us," and "our" refer to BU and the Stepp Lab.

Acceptance of These Terms

By using the App, you accept and agree to be bound by these Terms of Use. By using this App, you also accept and agree to comply with all applicable laws. If these Terms of Use are unacceptable to you, do not use the App.

We are not responsible for any treatment outcomes. We are not responsible for any therapy documented through use of this App.

We do not save or have any access to your data. When you download the App, all of the information entered will be stored only on your own device. We will have no access to it. This App is not a secure system and therefore it is not recommended that you enter identifiable patient information. It is recommended that you provide each patient with unique identifier for his or her Patient ID.

We are not responsible for any information you record using the App, including information that is deleted or otherwise lost, whether due to user error, software error or any defect in the App.

You may use the App and its contents only for the purposes and in the manner specified in these Terms of Use. You may not distribute, transmit, broadcast, publish, display or otherwise make the App available to others. You agree to use the App for only lawful purposes, in accordance with applicable laws and in a manner that does not infringe or violate anyone's rights.
