Monday, September 30, 2019.

Met at five minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Senator from Worcester and Middlesex, Mr. Tran, presented a request that when the Senate adjourns today, it do so in memory of Randy Pouliot of Gardner, Massachusetts.

Randy began his public service career at the Gardner Fire Department in 2000. Though he was ultimately left in 2003, he continued to show his devotion by visiting the Gardner team, where his son-in-law was eventually hired in 2014.

Randy continued to serve his community by working an additional sixteen years at the Leominster Fire Department. He was well known and loved by his fellow firefighters. He left behind a legacy of hard work and a dedication to the job. Randy was an individual who constantly volunteered to mentor and assist others, quickly developing a reputation for leading and teaching those who joined the force after him.

During his free time Randy sought only to help others, something that he and his wife Melanie shared, as they helped each year to coordinate the American Cancer Society Relay for Life. Randy also served as an honorary board member for the Cancer Support Fund of Central Massachusetts.

Randy enjoyed all outdoor past times, such as fishing, and four-wheeling, but his greatest joy was spending time with his family and his beloved Melanie.
