JOURNAL OF THE SENATE.

Monday, November 13, 2017.

Met at fourteen minutes past eleven o'clock A.M. (Mr. Brownsberger in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Brownsberger), members, guests and staff then recited the pledge of allegiance to the flag.

Pledge of allegiance.

Petition.

Ms. Chandler presented a petition (accompanied by bill) (subject to Joint Rule 12) of Harriette L. Chandler and Sarah K. Peake for legislation to provide tax relief to seniors while creating affordable housing;

Tax relief,-- seniors. SD2390

Referred, under Senate Rule 20, to the committees on Rules of the two branches, acting concurrently.

Reports of a Committee.

By Ms. L'Italien, for the committee on Consumer Protection and Professional Licensure, on petition, a Bill authorizing the city of Salem to grant 1 additional liquor license for the sale of wine and malt beverages not to be drunk on the premises (Senate, No. 2140) [Local approval received];

Salem,-- liquor license.

By the same Senator, for the same committee, on petition, a Bill authorizing the city of Salem to convert a liquor license for the sale of wine and malt beverages not to be drunk on the premises to a liquor license for the sale of all alcoholic beverages not be drunk on the premises (Senate, No. 2141) [Local approval received];

By the same Senator, for the same committee, on petition, a Bill authorizing the city of Salem to grant 1 additional liquor license for the sale of wine and malt beverages to be drunk on the premises (Senate, No. 2142) [Local approval received]; and

By the same Senator, for the same committee, on petition, a Bill authorizing the city of Salem to convert 2 seasonal liquor licenses to annual licenses for the sale of all alcoholic beverages to be drunk on the premises (Senate, No. 2143) [Local approval received];

Beverly,-- liquor license.

Reports of Committees.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A Bill authorizing any town or city to designate a check-off box on certain tax bills to fund a Veterans Memorial and Patriotic Celebration Fund (House, No. 4019,-- on petition),-- was read.

There being no objection, the rules were suspended, on motion of Mr. Tarr, and the bill was read a second time and ordered to a third reading.

A petition (accompanied by bill, House, No. 4031) of Carole A. Fiola and Michael J. Rodrigues relative to designating a certain bridge in the city of Fall River as the Ronald Costa bridge,-- **was referred in concurrence, under suspension of Joint Rule 12, to the committee on Transportation.**

Fall River,-- Ronald Costa bridge.

PAPER FROM THE HOUSE

Engrossed Bill.

An engrossed Bill authorizing the town of Lynnfield to convey certain land (see House, No. 4010) (which originated in the House), **having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and signed by the Acting President (Mr. Brownsberger) and laid before the Governor for his approbation.**

Bill laid before the Governor.

Report of a Committee.

By Ms. Spilka, for the committee on Ways and Means, that the House Bill relative to advancing contraceptive coverage and economic security in our state (ACCESS) (House, No. 4009) (also based on Senate, No. 2204),-- ought to pass, with an amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2210; and by inserting before the enacting clause the following emergency preamble:-

Contraceptive coverage.

“Whereas, The deferred operation of this act would tend to defeat its purpose,

which is to provide forthwith contraceptive coverage and economic security in the commonwealth, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public health and convenience.”

There being no objection, the rules were suspended, on motion of Mr. Lewis, and, after remarks, the bill was read a second time and, after further remarks, was amended, as recommended by the committee on Ways and Means.

The bill, as amended, was then ordered to a third reading, read a third time and passed to be engrossed, in concurrence, with the amendment, its title having been changed by the committee on Bills in the Third Reading to read as follows: “An Act relative to advancing contraceptive coverage and economic security in our state”.

Sent to the House for concurrence in the amendment.

Order Adopted.
