By Mr. Galvin of Canton, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint

Rule 12 be suspended on the petition of Robert F. Fennell relative to low-voltage electrical or alarm system contracting permitted by local enforcement agencies. Emergency Measure.

The engrossed Bill establishing a sick leave bank for Deborah Clay, an employee of the Trial Court (see House, No. 3764, amended), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble. Deborah

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 6 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the House) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate. Bill

Engrossed Bill.

The engrossed Bill relative to the creation of a treasurer-collector in the town of Plainville (see Senate, No. 1961) (which originated in the Senate), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate. The Senate Bill establishing a town administrator in the town of Plainville (Senate, No. 1962) (its title having been changed by the committee on Bills in the Third Reading), reported by said committee to be correctly drawn, was read a third time; and it was passed to be engrossed, in concurrence.

The House Bill establishing a sick leave bank for Robert A. Montalvo, an employee of the Department of Correction (House, No. 3824), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it in line 7 by striking out the words "Massachusetts Department of Correction paid sick" and inserting in place thereof the words "extended illness"; and by inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of correction, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendments were adopted; and the bill (House, No. 3824, amended) was passed to be engrossed. Sent to the Senate for concurrence.
