Remarks of Minority Leader Bruce E. Tarr.

On November 1st, 2017, it was announced that students from The Academy at Penguin Hall in Wenham won the first place prize in the first ever Schools Economics Challenge with their video entitled "Exploring Tragedy of the Commons at Gloucester Seaport". This competition was created by two economics teachers from London and Australia in collaboration with The CORE Project, which produces electronic economic textbooks. The group challenged high school students to make a three minute video on a topic related to where they live incorporating the work of a famous economist and materials from their economics textbook. The challenge took on an international quality with students from all over the world submitting videos for consideration.

Remarks of Minority
Leader Bruce E. Tarr.

The winning team consisted of seniors Leah Humphreys, Micaela Trzcinski, and Kathryn Ward, and juniors Marietta Atkins, Meghan Curtin, and Elaine Turner. The students examined the struggle between maintaining fish stocks in Gloucester and apportioning fishing rights. The video included interviews from two conflicting views: those regulating fishing permits and fishermen whose lives are affected by the changes in regulations. The team was able to interpose these two contradictory sides while still highlighting the importance of conservation and the dangers of overfishing.

The Academy at Penguin Hall is an independent all-girls high school that opened in September 2016. The campus is located on 50 acres in Wenham, Massachusetts. It serves students from over 40 communities and prides itself on having a creative and supportive community. I want to congratulate these students on winning the first place prize and highlighting a very important issue in our coastal communities.

Adjourn In Memory of Police Officer Michael J. Lee

The Senator from Worcester and Norfolk, Mr. Fattman, moved that when the Senate adjourns today, it do so in memory of Webster Police Officer Michael J. Lee, 38, of Webster, who tragically passed away on October 8th.

Officer Lee was a 10-year veteran of the Webster Police Department and had previously served with the Falmouth Police Department. Michael was a 1997 graduate of Bartlett High School where he was co-captain of the football team and a member of the basketball team. He went on to attend Plymouth State College where he was a member of the football team. Michael graduated from the Massachusetts State Police Academy in June of 2006. He received several citations and awards during his career in law enforcement. Michael was an avid outdoorsman and was co-owner of Reaper Tactical LLC Firearms Training with his close friend, Josh Collins of the Webster Police Department.

He is survived by his mother, Dorothea (Scranton) O'Day Sullivan, her husband, Robert, of Bourne; his father, Ken Lee, of Brookfield; two brothers, Shawn Sandgren, his wife, Joann, of Southbridge, and Josh Lee and his wife, Megan, of Chicopee; his girlfriend, Kaitlyn Dibuono, of Webster. Michael also leaves behind many friends and a large, loving extended family, including his second family, the entire Webster Police Department.
