An Act criminalizing the trafficking of carfentanil.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 31 of chapter 94C is hereby amended by inserting after clause (3) of  
2 paragraph (b) of Class B the following clause:-

3           “(3 ½) Carfentanil”

4           SECTION 2. Section 32E of chapter 94C is hereby amended by inserting in subsection  
5 (b), in line 42, after the words, “paragraph (a),” the following words:-

6           “ clause (3 ½) of paragraph (b),”
