JOURNAL OF THE HOUSE.

Wednesday, July 19, 2017.

Met according to adjournment at eleven o'clock A.M., with Mr. Kafka of Stoughton in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by Father Rick Walsh of the Paulist Center of Boston, Chaplain of the House, as follows:

Good and Gracious God, we pray today for our House membership and for their staff. Guide them in their efforts to craft good and just legislation.

Prayer.

We give thanks for our heritage of Patriotic courage and daring. Today, however we recall how such bravery, without careful planning caused great harm to many citizens of colonial Massachusetts.

On this day in 1779, the Penobscot Expedition consisting of 44 ships, 2,000 sailors and mariners and over 1,000 militia was launched from Boston. The goal was to capture a small British fort at the mouth of the Penobscot River in what is now the state of Maine. Without consulting Continental military officials, this large company led by famous names in Massachusetts history including Saltonstall, Wadsworth, Lovell and Revere, met utter defeat.

From the battle and a forced retreat through the wilderness more than 470 men lost their lives. All the ships were destroyed except one that was captured by the British. It was considered the worst naval disaster in American history until the attack on Pearl Harbor.

Many lessons were learned from that ill-fated campaign.

May God continue to bless our Commonwealth.

The engrossed Bill establishing the Massachusetts pregnant workers fairness act (see House, No. 3680, amended) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

Motion to Discharge a Certain Matter in the Orders of the Day.

The report of the committee of conference on the disagreeing votes of the two branches, with reference to the Senate amendment (striking out all after the enacting clause and inserting in place thereof the text contained in Senate document numbered 2097) of the House Bill to ensure the public health and safety of patient and consumer access to medical and adult use of marijuana in the Commonwealth (House, No. 3776), recommending passage of a Bill to ensure safe access to medical and adult-use of marijuana in the Commonwealth (House, No. 3818), was considered, under suspension of Rule 47, on motion of Mr. Cusack of Braintree.

Pending the question on acceptance of the report, Mr. Hill of Ipswich asked for a count of the House to ascertain if a quorum was present. The Chair (Mr. Donato of Medford), having determined that a quorum was not in attendance, then directed the Sergeant-at-Arms to secure the presence of a quorum.

Subsequently a roll call was taken for the purpose of ascertaining the presence of a quorum; and on the roll call (the Speaker being in the Chair) 142 members were recorded as being in attendance.
