Thursday, July 27, 2017.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Moran of Boston in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Statement of Representative Walsh of Framingham.

A statement of Mr. Walsh of Framingham was spread upon the records of the House, as follows:

MR. SPEAKER: I would like to call to the attention of the House the fact that I was unable to attend the formal session on July 26th, 2017.

Yesterday, the House voted on An Act relative to simulcasting and racing (House, No. 208), to extend simulcasting and allow live racing to continue in Massachusetts. Had I been able to vote in the formal session, I would have voted YES on this bill.

I would have voted No on Representative Jones of North Reading's further amendment to the Governor's amendment on An Act relative to employer contributions to health care (House, No. 3288); and I also would have also voted NO on the Governor's amendment, regarding a \$200 million assessment on employers needed to balance the budget.

Had I been able to vote on Chairman Sanchez's amendment to this bill I would have voted YES.

My missing of roll calls yesterday was due entirely to the reason stated.

Emergency Measure.

The engrossed Bill establishing a sick leave bank for David Banks, an employee of the Trial Court of the Commonwealth (see Senate, No. 2111), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.

Subsequently, the Senate having concurred in adoption of the emergency preamble, the bill (which originated in the Senate) was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.

The House Bill establishing a sick leave bank for Mary Sorensen, an employee of the Department of Mental Health (House, No. 3837), reported by the committee on Bills in the Third Reading to be correctly drawn, was read a third time.

Pending the question on passing the bill to be engrossed, Mr. Speliotis of Danvers moved to amend it by inserting before the enacting clause the following emergency preamble:

“*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to establish forthwith a sick leave bank for a certain employee of the department of mental health, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.”.

The amendment was adopted; and the bill (House, No. 3837, amended) was passed to be engrossed. Sent to the Senate for concurrence.
