Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Appointment to a Special Commission.

The Speaker announced that he had appointed Representative Cantwell of Marshfield to the special commission on behavioral health promotion and upstream prevention established (under Section 193 of Chapter 133 of the Acts of 2016) to investigate evidence-based practices, programs and systems to prevent behavioral health disorders and promote behavioral health across the Commonwealth. Mr. Scaccia of Boston presented a petition (subject to Joint Rule 12) of Angelo M. Scaccia for legislation to establish a sick leave bank for Francisco Melendez, an employee of the Department of Youth Services; and the same was referred, under Rule 24, to the committee on Rules.

defibrillators.

The Senate Bill requiring automated external defibrillators in schools (Senate, No. 2449, amended), came from the Senate with the endorsement that said branch had concurred with the House in its amendment (striking out all after the enacting clause and inserting in place thereof the text contained in House document numbered 4719), with further amendments in section 1, in line 3, striking out the word "Each" and inserting in place thereof the following: "Notwithstanding section 27C of chapter 29 of the General Laws or any other general or special law to the contrary, each";

In lines 16, 17 and 18, striking out the words "public schools a list of grants and other funding sources that a public school may access" and inserting in place thereof the words "school districts, vocational districts, charter schools, approved private day or residential schools and collaborative schools a list of grants and other funding sources that are available";

In lines 19 to 26, inclusive, striking out the paragraphs contained in those lines and inserting in place thereof the following two paragraphs:

"(c) Any person, including an AED provider, who, in good faith, attempts to render emergency care under this section shall not be liable for acts or omissions in accordance with section 12V and 12V½ of chapter 112.

(d) The department of elementary and secondary education shall promulgate regulations and guidelines for the implementation, training, support and supervision of this section and shall collaborate with the department of public health to promulgate such regulations and guidelines."; and

In section 3 (as amended by the House) striking out the following: "July 1, 2018" and inserting in place thereof the following: "September 1, 2017".

The Senate further amendments were referred, under Rule 35, to the committee on Bills in the Third Reading.

Residential
exemptions.

The House Bill relative to the residential exemption (House, No. 4717), came from the Senate passed to be engrossed, in concurrence, with an amendment inserting before the enacting clause the following emergency preamble:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is forthwith to provide for certain residential exemp-

tions, therefore, it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience."

The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading. Said committee then reported that the amendment was correctly drawn; and it was adopted, in concurrence.

The House Bill protecting the rights of custodial and other non-teaching employees of school districts (House, No. 2319), came from the Senate passed to be engrossed, in concurrence, with an amendment striking out all after the enacting clause and inserting in place thereof the following:

"Section 59B of chapter 71 of the General Laws, as appearing in the 2014 Official Edition, is hereby amended by inserting after the word 'chapter', in line 36, the following words:— ; provided, however, that the hiring, promotion and termination of employees in custodial, maintenance and other non-teaching positions shall be conducted in accordance with any governing collective bargaining agreement".

The amendment was referred, under Rule 35, to the committee on Bills in the Third Reading.

A petition (accompanied by bill, Senate, No. 2508) of Kathleen O'Connor Ives and James M. Kelcourse (with the approval of the mayor and city council) for legislation to authorize the city of Amesbury to issue three additional liquor licenses, was referred, in concurrence, to the committee on Consumer Protection and Professional Licensure.

The engrossed Bill establishing a sick leave bank for Theresa Casey, an employee of the Massachusetts Rehabilitation Commission (see House, No. 4729), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 7 to 0. Sent to the Senate for concurrence.
