An engrossed Bill establishing a sick leave bank for Philippe Fauche, an employee of the Department of Mental Health (see House, No. 3723, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,—was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

The bill was signed by the Acting President (Mr. Timilty) and sent to the House for enactment.

An engrossed Bill designating a certain bridge in the town of Lanesborough as the Sergeant Gregory Aloysius Noonan Bridge (see House, No. 1809, amended), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 2 to 0.

## Adjourn In Memory of Timothy J. Callahan

The Senator from Essex and Middlesex, Mr. Tarr, moved that when the Senate adjourns today, it do so in memory of Timothy J. Callahan, who died July 7, 2017, at the age of 96.

Mr. Callahan passed away peacefully at his home surrounded by his family. The son of Timothy E. Callahan and Katherine A. Walsh, Mr. Callahan was born in Rhode Island and completed his high school education at Boston College High School. After high school, he attended Boston College, graduating in 1942.

Graduating college at the height of World War II, Mr. Callahan enlisted in the United States Air Force. He served as a 1st Lieutenant in the Air Force during World War II fighting in the battles in Normandy, Northern France and Rhineland. He served from 1943-1945 as a pilot of the B-26 Marauder, flying 65 combat missions in the European Theater of World War II, far surpassing the general quota

of 25 missions. Over the course of his military career, Mr. Callahan survived two plane crashes. Throughout his service, he earned numerous awards and commendations including: the Silver Star, the Distinguished Flying Cross, the Air Medal, the Distinguished Unit Citation, the Medal of Humane Action and the Purple Heart. After many years of service, he retired as a Major in 1968 from the United States Air Force.

Even after leaving his post in the Air Force, Mr. Callahan served his community for 34 years as the Director of Veteran's Services for the town of North Reading, retiring from this position at age 89. His unrelenting commitment to his country and constant dedication to the town of North Reading will not soon be forgotten by those who knew him. He is survived by his wife, Genevieve E. Callahan; his son, Timothy Callahan Jr. and his wife Marie, grandfather to Julia, Timothy III, and William; as well as many other family members.
