No. H.4218 Summary:

This bill amends the Minimum Nutritional Standards for School Food Services (GL 69:1C) to require public elementary schools in low-income areas to serve breakfast for children who are not already eligible for free or reduced-price breakfast. The price must be at least equal to the cost of providing the food. The bill (1) requires that the state will reimburse cities and towns for breakfasts, (2) requires schools to serve breakfast if at least 60% of students are eligible for free/reduced price breakfast under the federal lunch program, and (3) allows schools to select the breakfast service model best suited to their students.
