*Adjournment in Memory of Judith Rockwell.*

The Senator from Cape and Islands, Mr. Cyr, presented a motion that when the Senate adjourns today it do so in memory of Judith Rockwell of West Barnstable.

Judith Rockwell passed away on March 14, 2021. She was 89 years old.

Judith was born in 1932 in Middlebury, Connecticut. She graduated from Northfield School and began a decades-long career in banking. During this time, she met her first husband, Howard Kittredge, and gave birth to her daughter Wendy Kittredge Northcross and her son Todd Howard Kittredge. In 1967, she and her children moved to Cape Cod, where Judith met her beloved husband James Rockwell. Three years later, she began working for the First National Bank of Yarmouth in West Yarmouth. In 1978, Judith and her husband moved to St. Thomas, U.S.V.I. and ran a restaurant in Red Hook and a day charter boat together. In 1984, they moved to Florida, where they taught Sunday school and ministered in nursing homes. Judith also worked at the Sun Trust in Florida until 1996. Finally, Judith and her husband moved back to the Cape in 2005 to be closer to Judith's children. Judith continued her involvement in faith groups, joining West Parish of Barnstable and volunteering for the Rooster Crows church fair craft group.

In her free time, Judith loved to spend time in her garden, reflecting her family's long history of Scottish farmers. When she wasn't gardening, she spent time on Sandy Neck beach and reading all genres except fiction. She was deeply devoted to the Christian faith and loved spending time with her family, especially her grandchildren and two great-granddaughters.

Judith is survived by her husband James, her daughter Wendy and son-in-law Van Northcross, her son Todd and daughter-in-law Pamela Williams, her grandchildren Christopher and Alexis Northcross Bender, and her granddaughters Kate and Lainey. She was a beloved mother, wife, friend, and neighbor. She will be remembered for her warmth, faith, and graciousness. May we take a moment to reflect on and appreciate Judith's life and career and her contributions to the Cape Cod community.
