*Ordered,* That notwithstanding Senate Rule 7 or any other rule to the contrary, the House Bill making appropriations for fiscal year 2021 to provide for supplementing certain existing appropriations and for certain other activities and projects (House, No. 3871) (the committee on Ways and Means having recommended that the bill be amended by striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2480) shall be placed in the Orders of the Day for a second reading on Thursday, June 24, 2021.

Procedural order.

All amendments shall be filed electronically in the office of the Clerk of the Senate by 11:00 A.M, on Wednesday, June 23, 2021. All such amendments shall be second reading-amendments to the Senate Ways and Means new text (Senate, No. 2480), but further amendments in the third degree to such amendments shall be in order. The Clerk shall further specify the procedure and format for filing all amendments, consistent with this order.

After the bill as amended is ordered to a third reading, it shall immediately be read a third time and the question shall then immediately be on passing it to be engrossed, and no amendments shall be in order at the third reading of the bill unless recommended by the committee on Bills in the Third Reading.
