Monday, May 18, 2020

Met at twenty-four minutes past eleven o'clock A.M. (Mr. Rush in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Rush), members, guests and staff then recited the pledge of allegiance to the flag.

Emergency Preamble Adopted.

An engrossed Bill establishing a sick leave bank for Jessica Zamansky, an employee of the department of transitional assistance (see Senate, No. 2603), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,-- was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted in concurrence, by a vote of 3 to 0.

PAPER FROM THE HOUSE.

The House Bill addressing COVID-19 data collection and disparities in treatment (House, No. 4672, amended),-- came from the House with the endorsement that the House had concurred in the Senate amendment striking out all after the enacting clause and inserting in place thereof the text of Senate document numbered 2703, *with a further amendment* striking all after the enacting clause and inserting in place thereof the text of House document numbered 4710.

After remarks, Mr. Rodrigues moved that the Senate concur with the further House amendment with a *still further amendment* striking all after the enacting clause and inserting in place thereof the text of Senate document numbered 2708.
