Adjournment in Memory of Robert W. Horacek.

The Senator from Hampden and Hampshire, Mr. Velis, presented a request that when the Senate adjourn today, it do so in the memory of Robert W. Horacek who passed away on October 31, 2021.

Bob grew up in West Springfield and Agawam and was a proud graduate of Agawam High School and the University of Massachusetts. A business major, he started his own sales agency, Prime-Line Marketing, Inc. in 1982, a successful local business that has operated for 39 years.

In 1995, Bob moved to Southwick, where he began a long and dedicated career of public service.

Bob's service to Southwick spanned over 22 years, with stints on the town's Finance Committee, Capital Expenditures Committee, Community Preservation Community, Open Space Committee and Cable Advisory Committee. He loved Southwick and was known far and wide for his dedication to preserving and protecting the town. Bob was also a minister for the Universal Life Church and married seven couples throughout the community, including his son "RJ" and his wife Cynthia.

A devoted husband, father, grandfather, brother and uncle, Bob was an honest, loving, supportive and caring man. He lived life on his own terms, and loved golfing, his cars, and most of all politics.

Bob is survived by his loving wife of 46 years, Sharon Hopkins Horacek, his son Mark Peter, his son RJ and wife Cynthia, his two granddaughters Ilona Olivia and Isabella Juditha Horacek, his brother Dean and wife Joanne, his sister Sherry Kreps and husband David, and his sister Ellen Sousa and husband Rick, in addition to many nieces, nephews, cousins, extended family members and friends.

Bob's commitment to Southwick, to his community, and to his friends and family, will never be forgotten. We all mourn his loss.

Adjournment in Memory of Joseph "Joe" Cody.

The Senator from Norfolk, Bristol and Plymouth, Mr. Timilty, moved that when the Senate adjourns today it do so in memory of Joseph "Joe" Cody.

Joseph "Joe" Cody of Braintree, formerly of Hyde Park and East Boston, passed away surrounded by his loving family on August 11, 2021, at the age of 91. During his nearly 50 years of dedicated service to the Commonwealth, Joe always exhibited a strong work-ethic. Throughout his life, he always showed a genuine love of people.

Joe was a hard-working teacher, an incredibly kind social worker, and a dedicated

probation officer in the Massachusetts Trial Court. For instance, while working in a maximum-security unit for boys and a detention center for girls, he encountered hate but also yearnings for compassion and love.

In addition, Joe served for eight years with the Department of Youth Services. Most importantly, Joe, compassionately, served in the Norfolk County Superior Court's Department of Probation. There, he conducted pre-trial and post-trial investigations, completing social histories as an aid to sentencing decisions, rendered by the presiding judges.

In 1990 he was recognized as the Trial Court Employee of the Year.

Earlier in Joe's distinguished life, Joe graduated from St. Paul Seminary in Minnesota with a degree in philosophy, earning a master's degree a year later.

On a personal note, Joe was, also, a great storyteller. He is quoted as saying, "I love telling stories to anyone who will listen."

Putting pen to paper, Joe compiled the stories he had accumulated after almost 50 years in the field of human service and wrote a memoir recalling his life and vocation. In his *A BOOK ABOUT ME AND THEM*, he wrote about people who came into his life through the criminal courts of Massachusetts. Specifically, he wrote about everyday people who had experienced the adversities of life, pivoting to unorthodox means by which to overcome those obstacles. Sometimes, those means included breaking the law. His career included many stories showing his dedication toward working outside conventional means.

Since retiring in 2005, he enjoyed exercising at his health club, taking long walks, and fishing.

Joe was the beloved husband of 62 years of Mary (Murray) Cody, loving father of Mary T. Cody of Braintree, Joseph C. Cody and his wife Denise of Braintree, Barbara Daly and her late husband Stephen F. Daly of Foxboro, Kathleen McLaughlin and her husband Steven of Foxboro, and Joanne Scaramuzzo and her husband John of Dedham.

In addition, Joe was the devoted brother of Catherine Sexton and her late husband Paul "Red" Sexton of East Boston and Mary Willard and her husband Bob of Andover.

Moreover, was the son of the late Joseph T. and Catherine G. (Bagley) Cody.

In addition, Joe was the cherished grandfather of Joseph, Nicholas and Shawn Cody, Catherine and William Daly, Erin and Steven McLaughlin and Jill, Johnny, and James Scaramuzzo. Joe is, also, survived by his nieces, nephews, extended family, and friends.
