## RE: H.243/S.123, An Act expanding access to adoption

Dear Chair Finn, Chair Gomez, and Members of the Committee:

As the Director of the Office of the Child Advocate (OCA), I appreciate the opportunity to submit testimony today in support of H.243/S.123, *An Act expanding access to adoption*. The OCA's mission is to ensure that the Commonwealth's children receive timely, appropriate, and quality services from the state agencies that serve them. With the office's mission in mind, I respectfully request the favorable release of H.243/S.123 from the Joint Committee on Children, Families and Persons with Disabilities.

This legislation would enact a simple procedural fix to allow a child to be adopted by any appropriate kin, when it is in the child's best interest. Currently, an antiquated law prevents children from being adopted by a sibling, nephew, or niece. Those family members are only able to obtain guardianship over the child, which is not a permanent legal option. Passage of H.243/S.123 will increase opportunities to achieve permanency for many of the Commonwealth's most vulnerable children.

Today in the Commonwealth, there are approximately 2,800 children in foster care with a goal of adoption.<sup>1</sup> Sadly, many of them will move from foster care placement to foster care placement and never end up being adopted. Updating the law to allow for all family

members to adopt will give these children an increased opportunity for a permanent stability and safety through kinship adoption. The pre-existing relationship between a relative caregiver and a child is one of the many factors that can make kindship care a positive experience for vulnerable children. Kindship caregivers know the child's history and unique needs, which can lessen the trauma of being separated from one's parent. Maintaining familial ties and cultural traditions can also be reassuring for the child, even if the child and the relative caregiver are just getting to know each other. The Commonwealth is overdue to seize on the opportunity to increase legal permanency for children by passing H.243/S.123.
