asthma.** By the same member, for the same committee, on Senate, Nos. 1016, 1056 and House, Nos. 2066, 2069 and 2086, a Bill relative to improving asthma in schools (House, No. 2066, changed in line 1 by striking out the year “2008” and inserting in place thereof the year “2012”, and in line 61 by striking out the year “2012” and inserting in place thereof the year “2014”).

**Folic acid,—
awareness.** **By the same member, for the same committee, on House, Nos. 1952 and 2103, a Bill relative to folic acid awareness and birth defects prevention (House, No. 2103, changed in section 1, in lines 3 and 4, by striking out the words “after section 224”, and in line 5 by striking out the figures “225” and inserting in place thereof the figures “230”).**

land.** The engrossed Bill authorizing the Division of Capital Asset Management and Maintenance to grant an easement upon land of the Commonwealth located in the town of Ware to the Massachusetts Water Resources Authority (see Senate, No. 1837) (which originated in the Senate), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 3 to 0. Sent to the Senate for concurrence.
