Testimony in Support of House Bill 502 and Senate Bill 764 Eric Buehrens Interim President & CEO Beth Israel Deaconess Medical Center July 8, 2011

Dear Chairman O'Flaherty, Chairwoman Creem and esteemed members of the Committee:

I am writing to express my support for HB 502/ SB 764, An Act Relative to Gender-Based Discrimination and Hate Crimes, which clarifies and makes explicit in our Commonwealth's antidiscrimination and hate crime laws that persons are entitled to equal protection under the law regardless of their gender identity or expression.

As Interim President and CEO of Beth Israel Deaconess Medical Center (BIDMC), every day I am proud of our legacy and ongoing commitment to meeting the health care needs of diverse, underserved populations. At BIDMC, we have a covenant to care for the underserved and to work to change disparities in outcomes and access to care. Indeed, we have a strong history of serving patients who have faced tremendously difficulty in accessing and utilizing our health care delivery system, and in this inclusive spirit, I ask for your support for this legislation.

In 1916, decades before merging with the Deaconess hospital, Beth Israel Hospital was established by the Boston Jewish community to meet the needs of a growing immigrant population. Since that time, BIDMC has committed needed resources and established itself as a leading hospital in providing culturally appropriate care for residents of the Commonwealth who have faced racial, ethnic, cultural, language, gender, sexual orientation, age and other barriers in accessing needed health care and treatment. Today, we strive to serve our patients compassionately and effectively, as we would like our family members to be treated when care is needed in either the community or tertiary setting. Further, we honor and celebrate the diversity of our workforce, and recently held our 18th Annual LGBT Achievement Awards and PRIDE celebration in which the entire BIDMC community honored this year's award recipients.

The Commonwealth, similarly, has a long tradition of pioneering antidiscrimination laws, including civil rights violations against perpetrators of hate crimes, and was among the first states in our nation to pass an antidiscrimination law. This created a strong foundation for many amendments over the years, but we have more work to do. Regrettably, transgender persons have been subjected to discrimination and even violence on the basis of their gender identity or expression. The legislation before you today will make clear that these victims of discrimination and violence are protected under our antidiscrimination and hate crime laws, and Massachusetts will join the many states that have already amended their laws to extend these protections.

I thank you for your attention to this important issue, and urge your favorable report of HB 502 and SB 764.*
