[Senate, July 24, 2008 – Text of the Senate amendment (Ethics and Rules) to the House Bill relative to mental health parity (House, No. 4423)]

IN THE YEAR OF TWO THOUSAND AND SEVEN

SECTION 1. Chapter 32A of the General Laws is hereby amended by striking out
 subsection (a) in section 22, as appearing in the 2006 Official Edition, and inserting in
 place thereof the following subsection:-

4 (a) The commission shall provide to any active or retired employee of the 5 commonwealth who is insured under the group insurance commission coverage on a 6 nondiscriminatory basis for the diagnosis and treatment of the following biologically-7 based mental disorders, as described in the most recent edition of the Diagnostic and 8 Statistical Manual of the American Psychiatric Association, referred to in this section as 9 the DSM: (1) schizophrenia; (2) schizoaffective disorder; (3) major depressive disorder; 10 (4) bipolar disorder; (5) paranoia and other psychotic disorders; (6) obsessive-compulsive 11 disorder; (7) panic disorder; (8) delirium and dementia; (9) affective disorders; (10) eating disorders; (11) post traumatic stress disorders; (12) substance abuse disorders; and 12 13 (13) autism.

14 The commission shall also provide to any active and retired employee of the 15 commonwealth who is insured under the group insurance commission coverage on a 16 nondiscriminatory basis for the diagnosis and medically necessary and active treatment of 17 any mental disorder, as described in the most recent edition of the DSM, that is approved 18 by the commissioner of mental health. 24 (a) An individual policy of accident and sickness insurance issued pursuant to 25 section 108, which provides hospital expense and surgical expense insurance, and a group 26 blanket or general policy of accident and sickness insurance issued pursuant to section 27 110, which provides hospital expense and surgical expense insurance, which is issued or 28 renewed within or without the commonwealth, shall provide mental health benefits on a 29 nondiscriminatory basis to residents of the commonwealth and to all policyholders 30 having a principal place of employment in the commonwealth for the diagnosis and 31 treatment of the following biologically-based mental disorders, as described in the most 32 recent edition of the Diagnostic and Statistical Manual of the American Psychiatric 33 Association, referred to in this section as the DSM: (1) schizophrenia; (2) schizoaffective 34 disorder; (3) major depressive disorder; (4) bipolar disorder; (5) paranoia and other 35 psychotic disorders; (6) obsessive-compulsive disorder; (7) panic disorder; (8) delirium 36 and dementia; (9)affective disorders; 10) eating disorders; (11) post traumatic stress 37 disorder; (12) substance abuse disorders; and (13) autism.

38 An individual policy of accident and sickness insurance issued pursuant to section 39 108, which provides hospital expense and surgical expense insurance, and a group 40 blanket or general policy of accident and sickness insurance issued pursuant to section 41 110, which provides hospital expense and surgical expense insurance, which is issued or 42 renewed within or without the commonwealth, shall provide mental health benefits on a 43 nondiscriminatory basis to residents of the commonwealth and to all policyholders 44 having a principal place of employment in the commonwealth for the diagnosis and 45 medically necessary and active treatment of any mental disorder, as described in the most 46 recent edition of the DSM, that is approved by the commissioner of mental health.

A health maintenance contract issued or renewed within or without the commonwealth shall provide mental health benefits on a nondiscriminatory basis to residents of the commonwealth and to all members or enrollees having a principal place of employment in the commonwealth for the diagnosis and medically necessary and active treatment of any mental disorder, as described in the most recent edition of the DSM, that is approved by the commissioner of mental health.

SECTION 16. All policies, contracts and certificates of health insurance subject
to section 22 of chapter 32A, section 47B of chapter 175, section 8A of chapter 176A,
section 4A of chapter 176B, or section 4M of chapter 176G of the General Laws that are
delivered, issued or renewed on or after July 1, 2009 shall conform with this act. Form
filings implementing this act shall be subject to the approval of the commissioner of
insurance.
