JOURNAL OF THE SENATE.

Thursday, February 8, 2007.

Met according to adjournment at eleven o'clock A.M. (Mr. Havern in the Chair) (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

The Chair (Mr. Havern), members, guests and employees then recited the pledge of allegiance to the flag.

Communication.

A communication from the Division of Local Services' Bureau of Local Assessment submitting its Biennial Report of Equalization and Apportionment 2006 (received Tuesday, February 6, 2007),— **was placed on file.**

PAPER FROM THE HOUSE.

Engrossed Bill.

An engrossed Bill authorizing the town of Westborough to release an easement over land (see House, No. 2017) (which originated in the House), having been certified by the Senate Clerk to be rightly and truly prepared for final passage, was passed to be enacted and was signed by the Acting President (Mr. Havern) and laid before the Governor for his approbation.

Recess.

There being no objection, at seven minutes past eleven o'clock A.M., the Chair (Mr. Havern) declared a recess; and at twenty-one minutes past twelve o'clock noon, the Senate reassembled, Ms. Spilka in the Chair (having been appointed by the President, under authority conferred by Senate Rule 4, to perform the duties of the Chair).

PAPERS FROM THE HOUSE.

Emergency Preamble Adopted; Engrossed Bill Enacted.

An engrossed Bill establishing a sick leave bank for Ann Brevik, an employee of the Department of Social Services (see Senate, No. 12), having been certified by the Senate Clerk to be rightly and truly prepared for final passage and containing an emergency preamble,— was laid before the Senate; and, a separate vote being taken in accordance with the requirements of Article LXVII of the Amendments to the Constitution, the preamble was adopted, in concurrence, by a vote of 3 to 0.

The bill was signed by the Acting President (Ms. Spilka) and sent to the House for enactment.

Subsequently, the bill, which originated in the Senate, came from the House with the endorsement that it had been enacted in that branch.

The Senate then passed the bill to be enacted; and it was signed by the Acting President (Ms. Spilka) and laid before the Governor for his approbation.

Adjournment in Memory of Anthony Manzelli.

Anthony Manzelli was the beloved husband of Jean F. (Murphy) Manzelli. Loving son of Mario and Marie (Garrasi) Manzelli of Somerville. Beloved father of Amy Manzelli and her husband Chad Turmelle of Pembroke, NH, Chris Manzelli of Kingston and Jenny Manzelli of Kingston.

Tony Manzelli, of Kingston, was a beloved teacher and dedicated lacrosse coach in Weymouth for over 30 years. With his contagious love for life, "Coach Manzelli" was a friend and idol to all who he taught and coached. Wearing the now famous orange hat, Manzelli was the father of lacrosse in Eastern Massachusetts and was inducted into the Lacrosse Hall of Fame in 1998. He will be greatly missed by Weymouth and the whole South Shore community.
